Rental of our Limousine and service is with full acknowledgment and agreement of the following terms and conditions:

Airport pickups: Additional charges may incur for waiting time for arriving flights. There is no extra charge for the first 15 minutes of delay. After 15 minutes there is an extra \$ 10.00 charge for every 15 minutes of waiting time. For all arriving flights, meet your driver at the baggage claim area. To avoid a no-show fee please do not leave the airport before calling the office for assistance. The number is: 215-862-2202. A \$20 surcharge will be applied to any trip before 6 am or after 10:30 pm and certain holidays. Trips made on the following holidays: New Year's Eve, New Year's Day, Christmas Eve, Christmas Day, Memorial Day, Labor Day, Thanksgiving and Fourth of July, will have a 25% holiday surcharge added to the fare, stops and waiting times.

No possession, sale or consumption of any type of narcotics or illegal drugs is permitted. Violations will result in immediate termination of contract and services and forfeiture of all paid deposits and fees for service. Seatbelts must be worn while the vehicle is in motion. We have a NO SMOKING policy in our vehicles.

Client and renter are responsible for his/her guests, for any damage to the interior and equipments of the vehicle. This is including but not limited to : gum, wine and alcohol spillage, vomiting, breakage of champagne, wine and drink glasses, breakage of decanters, breakage of lights, television, DVD, radio, CD player. Clean up and / or Repair and replacement of damaged items shall have a minimum charge of at least (\$250.00) two hundred fifty dollars. All passengers agree to behave in an orderly and well-behaved manner. Prestige Limousine LLC reserves the right to expel any person from the vehicle and/or terminate this contract in the event of a violation of any of these conditions by any passenger. In the event of such early termination, no portion of the rental fees shall be refunded.

While we are happy to let you bring personal compact disks, DVD's and other various personal items but we do not take any responsibility for items that are left in the vehicle during or after completion of the limousine rental period.

Prestige Limousine LLC shall not be held responsible for late arrival caused by (but not limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop-off information, and any situation beyond our control.

In the event any part of this contract is declared unenforceable, the remaining provisions of this agreement shall remain in full force and effect.

If the limousine rental is to be by a minor under the age of (18) eighteen, this agreement must be signed by either a parent or legal guardian over the age of (18).

All vehicles are quoted subject to availability at the time of booking. Rates are subject to change without notice. A deposit of 25% of the total amount is required at the time of booking and is nonrefundable. The balance is due at the time of the service.

Prestige Limousine LLC reserves the right to substitute the limousine type or the color of the vehicle at its own discretion.

All out of pocket expenses including two way tolls, Minimum \$5 parking, and at times a fuel surcharge will be added to you bill.

A cancellation fee equal to the trip cost will be charged for any cancellation made less than twelve hours before the scheduled pick-up time. All cancellations made after regular business hours **MUST CALL** the **emergency number** provided to cancel. A no-show fee equal to the trip cost, including applicable waiting time, will be charged when the passenger fails to show at the designated location.
